The policy states that individuals borrowing equipment provided by the Board will be held responsible for any loss or damage that may occur. In the event of any loss, theft, or damage to the equipment, it is the responsibility of the parent/quardian to cover the cost of repairs or replacement. As well, only approved software may be loaded onto a computer and use of equipment must be consistent with the Sir William Mulock Secondary School and York Region District School Board Computer / Internet Acceptable Use Policy.

Definition: For the purpose of this agreement board-owned equipment includes computer devices such as laptops, netbooks or other computer devices including all peripheral equipment associated with operating these devices.

Student and Parent / Guardian Agreement:

I/We acknowledge and agree that Sir William Mulock Secondary School and the York Region District School Board is the owner of the computer device provided to the parent/guardian and student listed in this agreement.

I We acknowledge and agree that the computer device will be returned to Sir William Mulock Secondary School upon request from school administration or when the student is no longer attending Sir William Mulock Secondary School.

I/We acknowledge and agree that the parent/guardian and student are responsible to follow the Sir William Mulock Secondary School and York Region District School Board Computer / Internet Acceptable Use Policy.

I/We acknowledge and agree that the student and parent/guardian must assume responsibility for any and all repairs or service as may be required for the computer device.

I/We acknowledge and agree that the student and parent/guardian must assume responsibility for the replacement cost of the computer device and the peripheral equipment (battery, plug, bag, cords) in the event it is lost, stolen, or because of damage that is beyond repair.
